Application Requirements

*ALL the following requirements must be fulfilled.

- (1) Must be a full-time, registered, master or doctoral student, as of April 1, 2015. You are not eligible to apply if you take a leave of absence from the university or if you are studying abroad (exchange programme, TSA, ISA, privately-financed exchange).
- (2) Must be registered as <u>a full-time student at WASEDA University</u> for the whole period of the internship programme.
- (3) <u>Must hold a nationality from one (1) of the OECD member countries.</u>

Application from students of non-member states will **NOT** be accepted.

(4) Must be able to speak fluent English (TOEFL iBT Score: 100~ IELT Score: 7.0~). Ability in French will be a plus.

(5) Participation in the programme must not interfere with your lectures, teaching

courses and research guidance. Please speak with your supervisor before you submit

your application.

(6) Must download, sign and submit a hand-written consent & agreement form in either

English or Japanese.

(7) Must purchase the designated Overseas Travel Insurance in case of accidents and

disease while attending the programme. Premiums are to be borne by the intern.

Other Important Internship Information

Number of Students: FIVE (maximum)

Internship Location: OECD Headquarters, Paris

Internship Period: From June, 2015 (TWO months minimum, SIX months maximum)

Duration may be determined between the selected interns and the OECD.

Salary and Expenses: There is no official salary provided by the OECD. It is the

responsibility of the student to pay all expenses including transportation,

accommodation, travel insurance, living expenses and such during the programme.

WASEDA University will provide a financial grant of up to 500,000 yen for each

successful candidate. More details will be announced after the selection is final.

Please note that government-sponsored foreign students, such as MEXT, will not be

permitted to receive full financial support from WASEDA University. Internship period

will be limited to two months. If you are a MEXT scholarship recipient, please check

with the staff in charge of scholarship on campus to confirm your eligibility.
