Master of Business Administration, Waseda University


Master in Management Grande Ecole, Ecole Supérieure de Commerce de Paris

Introduction of ESCP


Founded in 1819, ESCP (Ecole Supérieure de Commerce de Paris) Europe is the oldest business school in the world and has produced generations of leaders. In 1973, campuses in Germany (Berlin) and the UK (London) were created, and the pioneering model of the first multi-campus management school was born. Campuses in Spain (Madrid) and Italy (Torino) followed in 1988 and 2004 respectively. Today, over 100 partnerships with schools both in Europe and around the world complete this European calling in the context of an ever more intertwined globe. Only 1% of all the business schools are "triple-accredited" (EQUIS, AACSB, AMBA). ESCP Europe is one of the very rare few.

Selection Process

WBS will select the candidates from among the International MBA students who apply to the Waseda-ESCP Double Degree Program. Both schools will create a joint selection committee and will arrive at a final decision after interviewing the candidates.

Financial Considerations

Students participating in the Waseda-ESCP Double Degree program shall pay the <u>full tuition and fees to</u> <u>WBS</u>, including a 150,000JPY Double Degree Program registration fee. The students shall be exempt from paying such fees at ESCP.

In addition to the full regular WBS tuition and fees, the following fees will apply, and they must be paid by the Double Degree students themselves – a registration fee to ESCP for enrollment (around 1,500 Euro **subject to change*), travel expenses, accommodation, designated overseas insurance (Waseda & ESCP), health insurance and healthcare fees, living expenses and other necessary expenses.

#Exchange Rate: 1 Euro = About 165 JPY (Accurate as of October 29, 2024)

Important Note

For students enrolled in April to the IMBA program, the graduation period will be extended by one semester or more. Please note that the **full WBS tuition and fees will be charged for the extended semester** at ESCP, e.g. the 5th semester, for the IMBA program students enrolled in April.

Enrollment Status	The enrollment status of the WBS students will be "study abroad (being enrolled)" while they study at ESCP. The period of study abroad will be counted in the enrollment period. For the IMBA students enrolled in April, the graduation period will be extended by one semester or more.
Tuition	Students participating in the Waseda-ESCP Double Degree program shall pay the full tuition and fees to WBS , including a 150,000JPY registration fee and shall be exempt from paying such fees at ESCP. In addition to the regular WBS tuition and fees , the following fees apply, and they must be paid by the DD students themselves – a registration fee at ESCP for enrollment (around 1,500 Euro * <i>subject to change</i>) and the designated overseas insurance (Waseda / ESCP).
