Many stateless people are unable to do things that are often taken for granted – getting registered at birth, going to a school or a hospital, or getting married. 4.4 million people in the world are known to be stateless but the actual number is estimated to be much higher.

This year marks the 70th anniversary of the 1954 Convention relating to the Status of Stateless Persons, as well as the final year of UNHCR's #IBelong campaign. The number of State parties to the 1954 Convention is reaching the landmark of 100.

The majority of the states in the Asia-Pacific region including Japan has not acceded to the 1954 Convention, nor does it have a system to accurately identify who is stateless. Nevertheless, all the states in the region have ratified key international human rights treaties, and have also actively working on the 2030 Agenda for Sustainable Development contributing to the protection of stateless persons and improvement of their living conditions.

To highlight statelessness situations and some significant developments in the Asia-Pacific region, the panel is participated by experts and practitioners (including of statelessness background) from the Philippines, Thailand, Malaysia, and Japan. Please join us to discuss what can be done to improve the human rights and wellbeing of stateless persons in Japan and beyond.
