# How to Defer March 2026 Graduation (For Students Not Wishing to Graduate in March) [For School of Culture, Media and Society JCulP OS Students]

Starting in AY 2024, March graduation changed from an application-based system to an automatic system. <u>If</u> students fulfill the requirements for March graduation in the 2025 fall semester, they will automatically graduate in March 2026.

Please note that those who entered in Fall 2022 will NOT graduate in March 2026.

As a rule, once students have met the graduation requirements, they graduate and are no longer registered at the university (i.e., it is not possible to remain registered if you have fulfilled the graduation requirements). However, depending on your credit acquisition status, it may be possible to change when you will meet the graduation requirements by adjusting the courses for which you register and the credits you will acquire.

This document, which applies to JCuIP OS students in the School of Culture, Media and Society, explains how to defer March graduation if you could graduate automatically in March but do not wish to do so. If you do not wish to graduate in March, make sure you consult this document before you register fall semester courses.

Please note that in some cases there is no way to definitely defer March graduation due to your course registration status and in some cases your GPA will decrease if you defer March graduation.

## [If You Wish to Graduate in March]

Students who wish to graduate in March should consult "March 2026 Graduation Flow (For Students Wishing to Graduate in March) [For School of Culture, Media and Society JCulP OS Students]" instead of this document. Please be sure to check before registering for fall semester courses.

To graduate, it is necessary to have been registered for at least 4 years (8 semesters). In the following case, the student would not graduate in March.

## Verify the March Graduation Requirements

Students who fulfill all the requirements indicated below will automatically graduate in March.

## **March Graduation Requirements**

- ① At the end of the fall semester, the student <u>must have been registered for at least 3 years</u> <u>since promotion (since becoming a 2nd-year student)</u>.
  - \*Leave of absence periods and study abroad periods are not included in the number of years of registration.
- 2 At the end of the fall semester, the student must have obtained at least 124 credits required for graduation and fulfill all the requirements.
- ③ Full payment of tuition, etc. for courses through the fall semester must have been made.
  - \*Please note that if requirement [3] is not met, the student will be subject to administrative withdrawal as a result of removal from the school register due to unpaid tuition fees.

## 2. Check whether you meet March Graduation Requirement [1]

Verify whether you meet March Graduation Requirement [1]. The number of years of registration does not include leave of absence periods and study abroad periods that are not considered enrolment periods. If you do not meet March Graduation Requirement [1], it is not possible to graduate in September, but just in case, you should make sure to complete the process up to the next step ("3. Verify whether March Graduation Requirement [1] has been met (check Waseda Mail)").

## **March Graduation Requirements [1]**

At the end of the fall semester, the student <u>must have been registered for at least 3 years since promotion</u> (since becoming a 2nd-year student).

\*Leave of absence periods and study abroad periods are not included in the number of years of registration.

# 3. Verify whether March Graduation Requirement [1] has been met (check Waseda Mail)

By around 10:00 a.m. on Friday, September 5, 2025, a MyWaseda notification email with the subject indicated below will be sent to the Waseda Mail address of students who meet March Graduation Requirement [1] (graduation requirement relating to number of years of registration) at the end of the 2025 fall semester.

#### > Students who received the notification email indicated above:

If March Graduation Requirements [2] and [3] are also met in the fall 2025 semester, you will automatically graduate in March.

If you do not wish to graduate in March 2026, you should follow the procedure below and verify the March graduation deferral method.

# > Students who did not receive the notification email indicated above:

You will not graduate in March 2026. It is not necessary to defer March graduation as explained below. If you do not receive the notification email even though you met March Graduation Requirement [1] when you checked it yourself, make sure to contact the Administrative Office of the Faculty of Letters, Arts and Sciences by September 10. If you are unsure of when you can graduate, you should also contact the Administrative Office of the Faculty of Letters, Arts and Sciences.

## Report to your academic supervisor that you plan to defer March graduation

- Students who meet March Graduation Requirement [1] and wish to defer March graduation should report to their academic supervisor that "I am eligible for March graduation based on the number of years of registration, but I do not plan to graduate in March."
- After that, report to your academic supervisor as needed if your plan regarding March graduation changes, etc.
- Students who do not receive a notification email informing them that they meet March Graduation Requirement [1] are not eligible for March graduation in the first place, so they do not have to report anything in particular to their academic supervisor.

# 5. Verify your grades through the spring semester and verify missing courses and credits required to graduate

In order to defer March graduation, it is necessary for students who meet March Graduation Requirement [1] to <u>make</u> <u>sure they do not acquire all the credits and compulsory subjects required for graduation in the 2025 fall <u>semester (to avoid meeting March Graduation Requirement [2]).</u> To do so, you should first verify your credit acquisition status.</u>

In early September, grades for the spring semester are announced on MyWaseda's web grade report page. Check the number of credits you have acquired to date and the missing courses and credits required to graduate.

If you do not understand the web grade report page procedure, consult the following page:

On Check My Grades & Progress – Support Anywhere (waseda.jp)

Check your missing credits by clicking the "Credit Report" button on the web grade report page and compare the credits (for each **Category** and **Total**) in the "Required" column and "Included" column.

At the end of the fall semester, if the number of "Included" credits is equal to or greater than the number of "Required" credits for each Category and Total, you meet March Graduation Requirement [2].

You should consider <u>deferral methods</u> (3) and (4) <u>below as methods to be used in unavoidable circumstances</u> <u>only.</u> Both of these methods involve <u>deliberately obtaining a fail grade</u>, which is fundamentally not desirable. Furthermore, with deferral method (4), <u>you cannot be sure that you will defer March graduation</u>.

Take care with this method, as even if you deliberately aim for a fail grade, it is possible that it will not go according to plan and you will obtain a pass grade. Grades are determined based on the judgment of the course instructor, and you cannot request a fail grade or the like.

# Register for fall semester courses

Complete course registration by the stated deadline as usual, based on the specified rules.

## <<Important>>

- If you are planning to graduate in the spring 2026 semester (in September 2026), you need to acquire all compulsory subjects and credits required for graduation in the spring 2026 semester. Plan your courses by taking into account the maximum number of credits for course registration in the spring 2026 semester. The maximum number of credits for course registration in the spring 2026 semester will vary based on the credits for which you register in the fall 2025 semester. Carefully verify the course registration guidelines, including any other course registration rules.
- Pay particular attention to the maximum number of credits for course registration for half a year and one year.

## Check the results of expected graduation to verify whether you have deferred March graduation

The results of expected graduation are announced around at the end of October. <u>Make sure to check them on the day of the announcement.</u> The announcement date is scheduled to be published on the school website around late September.

## Submit an Application to Issue a Certificate of Expected Graduation in September (only if necessary)

## [Important]

If your expected graduation was evaluated as "[Result of Judgment for Graduation] Status for Graduation (Completion) (September)," the application mentioned in this section is not required, so do not submit one.

For students who plan to defer March graduation using deferral method (3) or (4) and whose expected graduation evaluation result is "[Result of Judgment for Graduation] Status for Graduation (Completion) (March)," a Certificate of Expected Graduation in March is set to be issued. Students who require a Certificate of Expected Graduation for September 2026 graduation should submit an application in the period indicated below. If expected September graduation is evaluated and deemed permissible, it will be possible to issue a Certificate of Expected Graduation for September graduation.

#### [Important Note]

It may not be possible to defer March graduation even if you submit this application. If you meet the March Graduation Requirements in the fall semester even though you submitted the application, you will automatically graduate in March. If the application is accepted, "[Result of Judgment for Graduation] Status for Graduation (Completion) (September)" will be displayed on the web grade report page, but this does not mean that March graduation has been successfully deferred. To defer it, you need to make sure that you adjust the credits you will acquire and when you will meet the graduation requirements, referring to "6. Verify the March graduation deferral methods."

## Application to Issue a Certificate of Expected Graduation in September

## << Important>>

• In certain special cases, students may not be permitted to graduate in September 2026 even if they are expected to graduate in March 2026. In such cases, the "Application to Issue a Certificate of Expected Graduation in September" will be rejected, and the student should graduate in March 2026. (Example: Students who reach the permissible number of registration years in the fall 2025 semester (the maximum number of years students can register at the university is 8 years for regular students and 4 years for students who already hold a bachelor's degree) and cannot register for the spring 2026 semester, etc.)

# 10. Verify fall semester grades and Result of Judgment for March Graduation

Grades for the fall semester and Result of Judgment for March Graduation will be announced on the MyWaseda grade report page, so you should verify them there.

- Students for whom "[Result of Judgment for Graduation] Impossible to graduate (March)" or "[Result of Judgment for Graduation] Status for Graduation (Completion) (September) is displayed
