Role overview: Legal Apprenticeship 2017

- Issues related to consumer protection.
- Any other related task that the in-house Legal Team may request during the Legal Apprenticeship.

You will produce high-quality legal research and analysis work in a flexible, fast-paced environment. You will need to demonstrate that you have sound legal judgment, can learn quickly in a fast-paced environment, and can communicate properly and confidently both orally and in writing.

Minimum qualifications:

- Must be enrolled or graduated in a Bachelor's or Master's of Laws, or Juris Doctor degree.
- Be able to complete at least 8 weeks (negotiable) and up to 6 months at the Tokyo office.
