### **Greetings from the Director**



### Welcome to Waseda University Institute of Comparative Law

Masanori Okata Professor of Law 21st and current Director of the Institute of Comparative Law Waseda University September 2020-Present

The Institute of Comparative Law (ICL) at Waseda University was established in 1958. The purpose of the Institute is to conduct comparative research on the legal systems of Japan and other countries, and to contribute to research and education in the field of Japanese legal studies. Working towards these goals, the Institute has been systematically collecting material on the legal systems of other countries, including their statutes, case reports, and law journals, to build one of Japan's most impressive law libraries. With the development of Japan's social and economic systems and the evolution of its legal system, our mission has expanded. We aim to disseminate information on the development of contemporary Japanese law and Japan's legal system, and to raise critical legal questions of universal importance for discussion from a Japanese perspective.

At present, the Institute has more than 110 research members who are full-time faculty members at Waseda University, and over 150 research affiliates from outside the university. In addition, agreements have been concluded with the Institute of Law, Chinese Academy of Social Sciences; School of Law, Tsinghua University; Institute for Comparative and International Law, University of Melbourne; School of Law, Duke University; the Max Planck Institute for Foreign and International Criminal Law; the Korea Legislation Research Institute; and University College London (UCL). Exchange researchers from these institutions are welcome to work with us at the Institute. Scholars and researchers from other countries can arrange to visit the Institute through such channels as the International Affairs Division of Waseda University.

The Institute conducts three different programs: specific or individual events, group research projects, and multi-annual research that is carried out by the Institute as a whole.

- In terms of specific events, the Institute holds public lectures on a semi-monthly basis for which it
  invites legal academics from around the world who are at the forefront of research in various fields of
  law. In addition, our research affiliates contribute articles to our annual journal, the *Waseda Bulletin of Comparative Law*, or to our online publication, *Topics of Japanese Law*. Both publish articles in
  English for readers worldwide, and the topics are related to the contemporary Japanese legal system,
  such as recent Japanese legislation and important Japanese court judgments.
- 2. Concerning group research, 24 joint research projects are being conducted by our research affiliates and adjunct researchers, who are working together on comparative legal studies.
- 3. Since 2013, the Institute has been conducting a research project on law and sustainability, with emphasis on the Asian region. As a result, *Law for Our Sustainable World: Promoting "Law and Sustainability"*, edited by Tamio Nakamura, was published in August 2020. The research project is based on a critical view of modern states and their societies, the rapid economic development of which is considered the premise of social development. However, the economic development has accelerated the depletion of natural resources and environmental deterioration. Thus, the project aims to determine a new role for law and legal studies that will be instrumental in bringing about a balance between the economy, society, and the environment, to achieve a transition to a sustainable society that protects the interests of future generations. Economic activities go beyond nation-states, and the social problems that result from these activities inevitably extend beyond national borders. Thus, an effective legal response to the problem would require legal measures and/or regimes at national, macro-regional, and

global levels to work in a mutually reinforcing and complementary manner. In this research project, we have tried to conceptualize an Asian regional law/regime that will respond to some of the major cross-border problems. Since there is a lack of research on macro-regional legal responses in Asia, we will keep on studying the experiences of the European Union for lessons and inspirations.

The results of our various research projects are published regularly, in print and online. The print versions include our journal, *Hikaku Hogaku (Comparative Law Review)*, our comparative law book series, *Hikakuho Kenkyujo Sosho*, and our annual journal in English, the *Waseda Bulletin of Comparative Law*. We also publish online articles in English in *Topics of Japanese Law*. In addition, in 2016, we started two new online publications, *Waseda ICL Online Journal* and *Waseda ICL Online Forum*.

The ICL aspires to be a unique forum that will strengthen ties between legal scholars in Japan and other countries through its diverse research activities. We welcome research proposals and initiatives, as well as academic professionals, from all over the world.

### **Institute Research Project**

### Promoting the Study of Law and Sustainability (Fiscal year 2017-2020)

The ICL developed the four-year research project "Promoting the Study of Law and Sustainability" from fiscal year 2017 to 2020, expanding on the institute's previous project, "The Role of Law and Jurisprudence at the Turning Point of Sustainable Society: Prospects for Asian Regional Law", which was conducted from fiscal year 2013 to 2016.



The common concern of this project is to conduct a critical review of modern law, which has contributed to, or at least quietly condoned, results that threaten the survival of humankind and Earth itself. Research into individual issues is carried out by joint research groups bearing that common concern in mind.

This project collects and organizes empirical knowledge by broadly categorizing research groups into three sections. Empirical knowledge is conveyed to the research group specializing in theory; in exchange, that research group introduces a theoretical perspective to other research groups. In this way, the project as a whole conducts empirical research from a critical perspective on real phenomena that endanger the sustainability of the planet and humankind, looking at the merits, demerits, and possible reforms of modern law. We also aim to theorize this academic process.

This Institute-wide research project is an ambitious one that merits the creation of a new academic field, one which will encompass a critical review of modern law, along with direct efforts to address urgent contemporary issues, and is organized as follows:

- The research group on distortions in Japanese society: this research group chiefly focuses on domestic issues which threaten sustainability, and, maintaining a critical stance towards modern law, considers possible reforms to address these issues. (Research activities may also extend to relevant cross-border issues.)
- 2) The research group on cross-border distortions: this research group chiefly focuses on cross-border issues which threaten sustainability and, maintaining a critical stance towards modern law, considers possible reforms to address these issues. (Research activities may also extend to relevant domestic issues.)
- 3) The research group on legal theory relevant to law and sustainability: complementing the activities of research groups 1 and 2 above, this research group governs relations among research groups as a whole by analyzing each group's results, and by coordinating the direction of research from the perspectives of legal philosophy and legal history.

In 2018, cluster seminars were held regularly, and the research outcomes were presented in the ICL's 60th anniversary symposium held at Ono Auditorium on 29th and 30th September 2018. The symposium attracted an audience of about 130, and lively discussions between reporters and commentators took place.

The research moved into the second round in October 2018, and the results were reported at the summary symposium held on October 30, 2019 and published in August 2020 as the comparative law book series *Law for Our Sustainable World: Promoting "Law and Sustainability"*. In addition, on Saturday, July 18, 2020, a seminar commemorating the publication of the book was held online to prevent the spread of

the new coronavirus infection. In the future, the research outcomes will be sequentially returned to the education of undergraduate and graduate students (including LL.M. students). This Institute-wide research project will allow the participation of doctoral students and others, who will engage in research and education through joint research activities.

#### Sustainable Technology and Law (2019~)

The institute-wide research and education project "Sustainable Technology and Law" began full-fledged activities in 2019 as an extension of "AI/Robotics and Law", which began as a research group in 2018 in collaboration with the Faculty of Science and Engineering.

At present, attention is focused merely on the technical aspects of advanced technology, but it cannot be said that the legal system has necessarily kept pace with technological progress. In this project, we will examine the legal issues that need to be resolved and the legal system that should be developed when introducing advanced technology into society, from the perspective of both science and engineering and law.

In 2019, we first held a symposium in Tokyo on "Current Status and Challenges of Laws concerning AI and IT from the Perspectives of Civil Law, Criminal Law, Procedural Law and Financial Law", followed by an international symposium in Beijing with the Institute of Law of the Chinese Academy of Social Sciences on "New Technology and Law", in which Japanese and Chinese legal scholars discussed new technologies from the perspectives of civil law (auto-driving technology, auto-driving accidents and law), commercial law (virtual currency, fintech and law), criminal law (development, operation and utilization of AI and law), and procedural law (the introduction of IT in legal procedure). And in 2020, we were preparing to hold the second part of the symposium on "New Technology and Law" in Tokyo, but unfortunately, due to the global spread of the new coronavirus infection, the symposium had to be postponed.

We sincerely hope that the new coronavirus infection will be brought under control as soon as possible so that the interactions among researchers can be reinvigorated and deeper research would be viable again.

A Symposium for Celebrating the Publication of "Law for Our Sustainable World: Promoting 'Law and Sustainability' (Waseda University Comparative Law Study Series 48)" (event report)

In July 18, 2020, the symposium "Law for Our Sustainable World: Promoting Law and Sustainability" was held on online.

#### **Part I: General Introduction**

### (1) "Law for Our Sustainable World: Promoting 'Law and Sustainability'"

### NAKAMURA, Tamio (Director, Institute of Comparative Law)

At the symposium, Nakamura gave opening remarks and explained what the Study of Law and Sustainability means. According to his report, the earth is likely to become much more difficult for future generations to live on than it is for present generations, due to global warming, widening economic disparity, concentration of population in cities, and the collapse of local communities in rural areas. So, we need to think of ways to solve this problem from perspective of Legal Studies. This is the purpose of the Study of Law and Sustainability.

### (2) "Anthropocentrism in Law and Sustainability"

### KAKU, Shun (Professor of the Faculty of Law)

Kaku presented a paper on "Sustainability and Anthropocentrism in Law" from the standpoint of philosophy of law. He analyzed the following four points: 1) the significance of sustainability from the perspective of the concept of "human development," 2) the inevitability of anthropocentrism in a weak sense, 3) the legitimacy of promoting the value of nature through public policy making, and 4) the possibilities and limitations of the framework of legal rights. He concluded that "sustainability is a matter of human well-being that can be promoted through public policy making from the perspective of justice".

#### Part II: Land

### (3) "Metabolism and Law: A Perspective for 'Law and Sustainability'"

### YUDUZAWA, Yoshio (Professor of the Faculty of Law)

In the second part of the lecture, Yuduzawa discussed the following question: how should law as a linguistic world accept the providence of the non-linguistic world as a norm? He argued that the concept of ownership in agricultural land law could help in reconstructing the whole concept of ownership.

### (4) "Urban Development and Sustainability"

### KAMANO, Kuniki (Professor of the Faculty of Law)

Next, Kamano considered the legal issues of the urban redevelopment projects around Shibuya Station and the land readjustment project in Matsuo City from the perspective of Law and Sustainability. He doubted that huge structures in cities will become a negative legacy because of a declining and aging population. Then he argued that we should reexamine legal regulation of urban redevelopment.

### (5) "Urban Land Use (for Residence and Commerce) and 'Law and Sustainability'"

### AOKI, Noriyuki (Professor of the Faculty of Law)

Aoki pointed out that urban development policies grounded on sustainability might be tension with zoning laws that focus on controlling population density and regulate land uses As the solution of this tension, he argued for "smart codes".

### Part III: The Environment (6) "Climate Litigation: Its Potential and Obstacles" OTSUKA, Tadashi

Otsuka reviewed the contents of the Paris Agreement and the IPCC Fifth Assessment Report on climate change goals, and considered climate litigation in Japan, the United States, the Netherlands, and Germany. Finally, he pointed out issues related to climate litigation in Japan.

### (7) "Designing Institutional Agencies for Future Generations" SHINDO, Mahito (Junior Researcher of the Faculty of Law)

Shindo explained about sustainability and intergenerational equity, and argued that we should build "a system to incorporate the interests of future generations into current decision-making." He also explained a conception of a future generation institution and discussed the issues involved in introducing such an institution in Japan.

### Part IV: The Economic Market

### (8) "'Law and Sustainability' and Corporate Law"

### UEMURA, Tatsuo (Professor Emeritus of the Faculty of Law)

Uemura examined the contents of "Law and Sustainability and Corporate Legislation" from the perspective of whether humanitarianism is at the root of the basic theory of corporate legislation. He argued that, from the perspective of this theory, Covid 19 crisis "makes human activities difficult", but "favors acts inimical to humanity".

# (9) "Global Sustainability and Capital Markets: the Potential and Limits of ESG Investments" KURONUMA, Etsuro (Professor of the Faculty of Law)

Kuronuma defined ESG investment as "investing in companies that excel in environmental, social, and corporate governance" and explained that its purpose is "to ensure the sustainability of the earth by indirectly controlling corporate activities. However, he argued that it is difficult to make investments that aim to increase public value as well as profits. He then analyzed the reality of ESG investment in Japan.

### Part V: Social Care

# (10) "Ontological Ethics of the Care of Others: Vulnerability, Responsibility and Hospitality" MORINAKA, Takaaki (Professor of the Faculty of Law)

Morinaka pointed out that "the social practices of care makes everyone a party to them" and that "care must be given". And he discussed vulnerability, responsibility, and hospitality from three following perspectives: 1) when responsibility for care begins, 2) the inevitability of de-subjectification in caring relationships, and 3) the universalization of hospitality.

# (11) "Social Inclusion of People with Mental Illness: From the Perspective of 'Law and Sustainability'"

#### HASHIMOTO, Yuki (Associate Professor of the Faculty of Law)

Hashimoto focused on the ways that the Convention on the Rights of Persons with Disabilities dealt with the compulsory hospitalization for persons with mental disabilities, and argued that the law in many countries, including Japan, is problematic in that it grants liberties only to "rational" and "reasonable" persons.

# (12) "Toward a Sustainable Local Community: From a viewpoint of Legal System for Sharing Care-related Informaton"

# OKADA, Masanori (Professor of the Faculty of Law), and NAKATSUKA, Fujio (Senior Fellow of Nikkei Financial Technology Research Institute, Inc.)

Okada examined the sustainability of local communities as the foundation of our daily lives. He stated that in order to make communities sustainable, care with routine and expertise is essential. According to his argument, in order to make care with routine and expertise possible, it is necessary to: 1) make the

intentions of care recipients public through expertise, 2) create a mechanism to mutually open up the roles and responsibilities of the entities and institutions involved in care, and 3) develop a network infrastructure to share care information in a multilayered manner.

Nakatsuka reported on systems for sharing care information, comparing cases in Japan and Europe. In particular, he introduced examples of ICT use for team management and council-style activities, focusing on sharing of information, know-how and data.

Finally, Nakamura asked all the presenters what they thought the future challenges would be. The presenters' responses were as follows. (1) In Japan, not only climate change but also budget deficits will have a serious impact on future generations. We should explore ways to bring people together to solve this issue. (2) We should consider how the future generation institutions respond to international issues. (3) The traditional role of local communities has been to manage property, etc. In the future, local communities should be reconstructed from the perspective of how to make a large number of care groups work together.




### Symposia and Lectures

ICL disseminated the results of its research to relevant researchers, and more widely to students and the general public through symposia and public lectures. ICL continued to deepen its exchanges with interested parties both within and outside Waseda University.

In 2020, due to the spread of the new coronavirus infection, only one online seminar was held, and we were unable to hold any symposia of public lectures. In, 2019, more than 830 people (including more than 526 students) participated in ICL's 13 symposia; more than 623 people (including more than 354 students) participated in 29 public lectures. On June 20, 2019 (Thursday), the ICL's Event of Film Screening and Discussion "Discuss food loss (Film title: Wastecooking)" was held at Waseda Campus.

NAKAMURA Tamio explained the purpose of this film screening that he would like to make this event an opportunity to think about "food loss" as there were increasing interests in and efforts towards "food loss" in Japan and overseas.

In the film, a man, by driving a car which uses waste oil as fuel, visits various countries of Europe (e.g., Austria, Germany, the Netherlands, and Belgium), and tackles "food loss" (e.g., cooking ingredients left in the refrigerator at home, collecting wild grass in the city, insect food, and reuse of uncooked food in the cafeteria).

MIURA Hiroko introduced the following points regarding the current status and attempts for reducing "food loss".

- Awareness of "food loss" is rising internationally as is shown in the 2030 Agenda for Sustainable Development (SDGs) adopted at the 2015 UN Summit.

- In Japan, there are laws related to food loss, which aims to curb the generation of food waste and promote recycling (an act on promotion of reduction of food loss (*Shokuhin rosu no sakugen no suishin ni kansuru horitsu*), and food recycling law (*Shokuhin risaikuru-ho*)).

- One of the factors that causes "food loss" would be business practices in the food manufacturing industry, and wholesale/retail industry.

- The Ministry of Agriculture, Forestry and Fisheries has taken steps to reduce food waste ahead of the Ehomaki season this year.

- We are promoting measures to reduce "food loss" toward the Tokyo Olympics and Paralympics.

At the QA session, students and faculty staffs presented following views and actively discussed "food loss".

- In the film, there was a scene of collecting groceries which were no longer used as commodities or foodstuffs discarded in the trash. Would there be any legal challenge if we tried to collect waste food in Japan?

- Waste recycling is expensive. Companies are interested in "food loss" and are engaging with environmentally friendly efforts while the food

recycling law and ESG investment have been attracting attention.

- Companies would tend to over-produce commodities in order not to lose business opportunities. Against these trends, corporate social responsibility (corporate ethics) has come to be asked at the general meetings of shareholders.

- Changing the modern lifestyle and consumption behavior is a great social experiment. In the past, there was no "food loss" in Japan when food could be purchased at any time. Key points to solve challenges might be how to change the attitude of companies which prioritize profit pursuit and economic efficiency (including the food manufacturing process); and how consumers think and act on "food loss" (e.g., expiration date).

- There was a scene in the film where insects were cooked as ingredients. Could eating insects be a solution to the "food loss"? Is there any resistance to eating insects?

- I do not think that resistance to eating insects could be easily dispelled. Is there any possibility that eating insects might lead to social prejudice in areas without insect-eating habits? I do not think that insect food could be realized in near future.

- Locust Tsukudani (*Inago no tsukudani*) and bee cubs have been eaten in some parts of Japan. Traditional food culture remains in Japan. I think resistance to insect food could be changed by the business sectors' efforts. Insect-based diets could be an effective way to solve the problem of the low food self-sufficiency rate in Japan.

- The idea of effectively using natural products such as tree nuts to eliminate waste might have some potential as a means of solving the problem of "food loss". This might be an implication of the film "Wastecooking".

- "Food loss" due to the disposal of non-standard products is considered to be one of the important issues facing modern agriculture, including Japan.

The event was very successful with several opinions from the participants, including a comment that the event gave good opportunity to think about "food loss".



### Interdisciplinary Collaboration

The ICL is working to promote academic exchanges with some non-legal academic fields, collaboration with the school of law, graduate school of law and law school, and strengthening collaboration with other affiliated and external institutions.

Although we had to postpone all activities in prevention for the spread of new coronavirus infection, we can introduce some of the events held in 2019.

#### 1. Interdisciplinary events and public lectures



Events of film screening and discussion have been held since FY 2017. In FY 2019, "Discuss food loss (Film title: Wastecooking)" and "RBG – Discuss the roles of Supreme Court in Japan and US (Film title: RBG)" were held.

In the event of the film screening ("Wastecooking"), there was a scene that a man visited various countries of Europe (e.g., Austria, Germany, the Netherlands, and Belgium), and tackled "food loss"

(e.g., cooking ingredients left in the refrigerator at home, collecting wild grass in the city, insect food, and reuse of uncooked food in the cafeteria).

After the film screening, MAFF staffs introduced their efforts toward food loss, and lively discussions were held on what we could do with the food loss problems.

In the event of the film screening ("RGB"), the U.S. Supreme Court's female judge Ruth Bader Ginsburg's documentary film "RBG" (depicting resolute behavior as a lawyer and a judge to eliminate sex discrimination) and the case of discrimination-related lawsuits were introduced as discussions topics.

There were discussions comparing Japan and the US as to the elections of the supreme court's judges, their compositions, the roles of dissenting opinions, and the relationship between public opinion and democratic deliberation. Students presented several views and they made active discussions.

### 2. Thematic seminars

The thematic seminars have been held every year since FY 2017 as academic projects comparatively examining a theme selected among contemporary cutting-edge topics.

In FY2019, sports and law (6 seminars) were co-held with Yokogawa Toshio Kinen Kōkai Koza, at the timing of Rugby World Cup on September and Tokyo 2020 Olympic and Paralympic Games in 2020, following the "Scandinavia and Law" (FY2017) and "Fintech" (FY2018).

The themes included 1) responsibility and prevention in sports accidents, 2) current status and challenges of sports arbitration, 3) developments and trends of sports law in EU, 4) eliminating harassment, corporal punishment and violence in sports, 5) regulations on sports business and antitrust law and 6) developments of anti-doping system and challenges.
