Application Requirements	To have a score of GMAT or GRE To have sufficient English skills to follow lectures in English *For the required score, please ask the office.
Student Registration Status	The student registration of QTEM participants is treated as "study abroad (being enrolled)"*. Outgoing students pay the tuition and fees to the Graduate School of Economics, and do not have to pay to the host institution. Other fees (travel expenses, living costs, etc.) should be covered by the student. *The study abroad period will be included in the enrollment period. * As for credit transfer, students must follow the designated procedures after they come back from study abroad.

Documents needed for Application	 Submit the following ①-④ documents. ① Application Form (Designated form available at the Office) ② Score card of either GMAT or GRE * It must be original. The Office will return the score sheet upon request by the student. ③ Academic transcript ④ A score card from one of the following English proficiency tests: TOEFL (iBT) • TOEFL (PBT) • TOEIC • IELTS * Those who are native speakers of English or have received a degree from an institute of higher education (university or equivalent) in English-speaking countries are not required to submit test results.

Destination Allocation	You can choose 3 preferred destinations at the time of application. However, the final judgment whether the student will be accepted or not will be made by the QTEM office and the host institution.
