Application Requirements	<p>To have a score of GMAT or GRE</p> <p>To have sufficient English skills to follow lectures in English</p> <p>*For the required score, please ask the office.</p>
Student Registration Status	<p>The student registration of QTEM participants is treated as "study abroad (being enrolled)". Outgoing students pay the tuition and fees to the Graduate School of Economics, and do not have to pay to the host institution. Other fees (travel expenses, living costs, etc.) should be covered by the student.</p> <p>*The study abroad period will be included in the enrollment period.</p> <p>*As for credit transfer, students must follow the designated procedures after they come back from study abroad.</p>
