[Requirements]

Students must meet the two requirements listed below in order to take graduate courses.

- 1) Be a student in the School of Political Science and Economics in his/her 4th year or higher.**
(Students who have applied for graduation in three years and are in their 3rd year are also eligible.)
- 2) Fulfilling the application requirements of Special Entrance Examination for Master's Program in Graduate School of Economics.**

[Notes]

- Students can take up to 16 credits from Graduate School courses while they are undergraduate students.
- At the time of registration, students of the Graduate School of Economics will be given precedence.
- Regarding combined courses with the School of Political Science and Economics, students can take them as undergraduate courses, with the credits counting towards those required for graduation from the undergraduate course. Alternatively, students can take them as Graduate School courses taken in advance and transfer the credits after they enroll in the Graduate School of Economics. If students want to transfer the credits in the Graduate School of Economics, or if students want to apply for the Master's Program One-Year-Completion System, please make sure to meet the above requirements and register courses as Graduate School courses taken in advance.

[Treatment of Credits after enrollment in the Graduate School of Economics]

Credits taken as "Graduate School Courses Taken in Advance" can be transferred to the credits taken at the Graduate School of Economics by applying for a credit transfer after enrollment in the Graduate School of Economics. Please note that the application for the credit transfer should be made in a designated period in the 1st semester after enrollment in the Graduate School of Economics. If the application for credit transfer is approved, students cannot take the same course again after enrollment in the Graduate School of Economics.
