

# 2014年度 早稲田大学 私費外国人留学生授業料減免奨学金

早稲田大学は、私費外国人留学生を対象として、学業成績に重点を置いた授業料減免（年間授業料の50%）を本学奨学金制度の一環として実施します。

なお、この減免措置を受けようとする者は、必ず「2014年度 早稲田大学私費外国人留学生授業料減免奨学金申請書」を受け取り、申請を行わなくてはなりません。

申込みは、所属学部・大学院事務所で次のとおり手続きしてください。

申請書配布および提出先：所属の学部・大学院事務所

提出期限： 10月29日（水）（期限厳守）

提出書類：「2014年度 早稲田大学私費外国人留学生授業料減免申請書」  
（および必要書類一式）

## 申請資格：

本奨学金に申請する者で、かつ、申請時において早稲田大学の学部または大学院の修士・専門職学位および一貫制博士の正規課程に在籍し、出入国管理及び難民認定法別表第1の4に定める「留学」の在留資格を有する学業成績が優秀な私費外国人留学生であって、経済的理由により修学に困難があると認められた者。（2014年度後期に入学した者、または留学・休学等から復学した者に限る）

ただし、次の各号のいずれかに該当する者は対象から除外する。

- ①国費外国人留学生制度実施要項に定める国費外国人留学生
- ②区分制博士後期課程に在籍する者
- ③一貫制博士課程の3～5年生
- ④学費免除者である助手・非常勤講師
- ⑤日本学術振興会特別研究員DC採用者である者
- ⑥外国政府により派遣されている者
- ⑦企業、奨学金団体等により学費が負担されている者
- ⑧出席日数を勘案し、学業継続の意思がないと認められる者
- ⑨学業成績が不振で、成業の見込みがないと認められる者
- ⑩標準修業年限を超える者
- ⑪休学中の者
- ⑫留学中の者（申請時に日本にいる場合も、秋学期留学の場合は不可。在学扱いの留学は応募可。）
- ⑬採用（減免受給）年度の秋学期に在学しない者

# Academic Year 2014 Waseda University Partial Tuition-Waiver Scholarship for Privately Financed International Students

Waseda University offers tuition reductions for the privately financed international students who are eligible for this scheme. Whether you will receive 50% annual tuition deduction will depend upon the screening based on your academic performance and financial circumstance etc.

Students who wish to receive this tuition-waiver scholarship must get the Application Form and apply for it.

Where to obtain and submit your application:

Office of your undergraduate or graduate school

Deadline: October 29, (Wed)

Documents to be submitted:

"Application Form: Academic Year 2014 Waseda University Partial Tuition-Waiver Scholarship for Privately Financed International Students"  
(as well as other required documents)

Eligibility:

At the time of application, applicants must be enrolled in a regular undergraduate or graduate school program at Waseda University, they must have a residency status of "College Student", they must be privately financed international students with outstanding academic performance who are acknowledged to have difficulty pursuing their studies due to economic reasons, and also they must submit an application for this scholarship. **(only students who enter Waseda University in September 2014, or return from a leave of absence or studying abroad are eligible to apply).**

Note that those to whom any of the following apply are NOT eligible.

- (1) Japanese Government (MEXT: *Mombukagakusho*) Scholarship students
- (2) Doctoral course students
- (3) Students enrolled in a consistent five-year Doctoral Program(year 3-5)
- (4) Research associates
- (5) Recipients of Research Fellowship for Young Scientists (DC) from the Japan Society for the Promotion of Science
- (6) Students sponsored by foreign governments
- (7) Students whose school fees are being paid by an institution such as a corporation or scholarship foundation
- (8) Students who are regarded to lack the motivation to continue their studies, based on their attendance records
- (9) Students whose academic performance is poor and who are not expected to complete their degree
- (10) Students who have enrolled beyond the regular course term
- (11) Students on a leave of absence
- (12) Students studying outside of Japan (Students who are studying in Japan at the time of application for the scholarship but who will study abroad from the fall semester are not eligible. Application is permitted if the registration status is "Registered in School but Study Abroad.")
- (13) Students who are not enrolled in the fall semester of the year.
