### 『早稻田政治經濟學雜誌』英語論文執筆規程

2016年7月29日改定

『早稻田政治經濟學雜誌』への投稿原稿を執筆する際には、以下の様式にしたがうこと。

- a) 英語を使用し、原則として電子ファイル (PDF 形式) で作成し、A4 用紙に横書きで記述すること。論文本体とは別にカバーページのみのファイルを作成し、そこに、論文タイトル、投稿者の氏名および所属、投稿資格、要旨\*\*(英語 200 ワード程度)、メールアドレス、謝辞等を記入のこと。カバーページの体裁は投稿者が任意に設定のこと。
  - ※要旨は、必ず事前にネイティブチェックを受けてから提出すること。
- b) 論文の本体は、本文、付録、注、参考文献の順に記述すること。本体は 12 ポイント以上のフォントを使用し、ダブルスペースで記述するものとする。また、 図表、数式、注や参考文献等を含めた総ページ数は、原則として 30 ページ以内とする。
- c) 論文の本文には、氏名や所属等の投稿者が特定可能な記述をしないこと。

- d) 付録が複数ある場合には、本文中に A1, A2 のように付番して指示したうえで、本文の後、注の前に集めて提示すること。
- e) 注は本文中に上添の数字で順に付番の上で、付録の後、参考文献の前に一括して提示すること。記述の 形式としては、以下の A か B のいずれかを選択すること。

f) 参考文献は本体の巻末に集め、日本語参考文献(五十音順)および外国語文献(アルファベット順)に 通し番号を付けること。また本文中での引用は、著者名と通し番号を用いて行うこと。

## Waseda Journal of Political Science and Economics Instructions for Authors Writing Articles in English

Revised: July 29th, 2016

Authors are requested to follow the instructions below when writing articles for this journal.

a) Manuscripts in English should be prepared as an electronic file (PDF) and written horizontally in A4 format. Contributors must also create a separate document file for the cover page. This file must contain the paper title, the name(s) and institutional affiliation(s) of the author(s), the qualification for submission, an \*abstract\* (approximately 200 words), contact email address(es) and acknowledgments. The form of this page can be freely customized by each writer.

\*The abstract must be reviewed by a native English speaker before submission.

- b) The main body, appendices, notes, and bibliography of the manuscript must be presented in this order. Authors are required to use a font size of 12 points or larger and double-spacing. In principle, the length of an article (including charts, formulas, notes, bibliography, etc.) should not be more than 30 pages.
- c) Manuscripts must not include any author-identifiable information, such as names, institutional affiliations, etc.
- d) If there are several appendices in a paper, writers should assign each an individual letter and number (such as A1, A2 ...) in the main text, and present all appendices between the main text and the notes.
- e) All notes should be numbered by consecutive superscript numerals in the main body of the manuscript, and should be placed between the appendices and the bibliography. With regard to presentation of notes, authors can choose between A or B below.

- f) All references should be listed at the end of the article. Authors must provide numbers of Japanese documents, arranged in the order of the Japanese syllabary, and of foreign documents in alphabetical order. If a work is cited in the main text, name(s) of the author(s) and the number of the document should be included in the list of references.
