AFLSP Exchange Scholar - Student Commitment Letter

<Updated October 2016>

This Commitment Letter is to be signed by the AFLSP Exchange Scholar (hereafter the "Scholar") participating in the "Asian Future Leaders Scholarship Program" (hereafter the "Scholarship Program") and returned to Bai Xian Asia Institute (hereafter the "Institute").

Eligibility conditions and requirements for the AFLSP Exchange Scholar

- 1. To be eligible for the Scholarship Program, the Scholar must:
 - a. remain enrolled at the Sending and Receiving University¹ as a full time student for the duration of participation in the Scholarship Program;
 - b. not be a recipient of any other scholarship or any form of funding support by a third party, unless otherwise disclosed to and agreed with the Sending and Receiving University and the Institute;
 - c. not take up any paid employment, full-time or part-time, while enrolled at the Sending and Receiving University except otherwise disclosed to and agreed with the Sending and Receiving University and the Institute.
- 2. Upon acceptance of the scholarship offer, the Scholar agrees to satisfy the following requirements:
 - a. participate in the BXAI Summer Program, a 3-week summer camp to be held in August 2018². Travel, accommodation, and other necessary expenses will be covered;

¹ "Sending University" refers to the Institute's partner university in Japan, namely (1) Keio University; (2) Kyoto University; (3) Kyushu University; (4) The University of Tokyo; and (5) Waseda University, that the Scholar attends at the time of accepting the scholarship.

[&]quot;Receiving University" refers to the Institute's partner university in Mainland China, HK, Taiwan, and Korea, namely (1) Fudan University; (2) Hong Kong University of Science and Technology; (3) National Taiwan University; (4) Peking University; (5) Seoul National University; (6) Shanghai Jiao Tong University; (7) The Chinese University of Hong Kong; (8) The University of Hong Kong; (9) Tsinghua University; and (10) Zhejiang University, that the Scholar will undertake his/her overseas exchange at the time of accepting the scholarship.

² Scholars who are unable to attend the BXAI Summer Program in August 2018 may apply to the Institute for an exception to attend the BXAI Summer Program in August 2019 instead.



- b. participate in all mandatory programs as stipulated for the Scholarship Program at the Sending and Receiving University;
- c. complete a report in the form as provided by the Institute.

If the Scholar immediately. that he/she has	fails to fulfil any of the eligibility conditions and requirements, the scholarship will be terminated. In addition, the Scholar will be required to repay to the Institute any portion of the Scholarship received.
