# FIRST ASIAN WORKSHOP ON ECONOMETRICS AND HEALTH ECONOMICS



KYOTO JAPAN December 9-11, 2018



This series of workshops provides a forum for the development and dissemination of applications of econometrics and other quantitative approaches in health economics.

The workshop will follow the format of the long-running European Workshops on Econometrics and Health Economics, with a particular vision to: Promote health economics research with applied microeconomics focus in Asia; strengthen research network within the region; and develop research network with other regions.

#### The Workshop

The workshop program consists of up to 14 papers. Each paper is allocated one hour, made up of a presentation by the author, followed by a response from a discussant and general discussion. The number of participants will be limited to 40. Workshop participants will be expected to attend the whole of the meeting and play a role as either author, discussant or chairperson.

The workshop will begin with lunch on Sunday 9th December, followed by a keynote short course by:
